С	Q.	Now, next, we are moving to JG/JDM1, image 946. Members of the jury, this is your
		divider 8, page 2. We can deal with this swiftly, professor. Is that an image of a
		baseball cap with either the same patch, the same square patch we saw earlier or one
		materially identical attached to the front of it?
	A.	Yes, it would appear to be, yes.
_	Q.	So that is the ISIS flag on that cap.
D	А.	That is the ISIS flag once again, yes.
	Q.	Image 5, we do not, in fact, have this in our bundle. This is an image that we looked
		at earlier when we compared the patches on their clothing.
Е	A.	Sorry, which divider?
	Q.	You do not have it in the divider. It is on the screen though, professor.
	A.	Oh right, okay.
	Q.	So do we have there an image of four men wearing patches of the type that were
F		recovered from the bedroom of 102 Ramsay Street, each of them performing the
		raised finger gesture?
	A.	Correct, yes; that is what I identify there
	Q.	Is there a prayer context to that use of the gesture?
G	A.	No, I can see no ritualistic element in that.

	Q.	Now, we are next going to MST/06/JDM/1, first photograph, members of the jury, is
		in the bundle. It is at divider 7, page 1. Do those two men appear to be holding a

ъ	A.	Once again it appears a posed picture rather than a ritual context.
В	Q.	Then the next image, please, members of the jury, which is in the bundle also at page
		2. Three men including Mr. Syeedy in the middle performing that gesture. Is there a
		prayer context to that use of the gesture?
С	A.	None that I can identify, no.
	Q.	Next image over and we have this at page 3. You have commented on part of this
		"The war zone ends" and on whether the flag appears to be the same or materially
		identical. We can see Mr. Syeedy on the left with a raised index finger gesture. Is
		there any prayer context to that?
D	A.	None that I can identify.
	Q.	The next image, please, again you have commented upon the flag and the sign. Both
		men including Mr. Syeedy performing the raised finger gesture. Is there a prayer
		context for that?
E	A.	None that I can identify, no.
